Nominate  membership category - see descriptions below. Visit AAC website for more information about membership.

- Full membership - \$550 pa\***  
Full membership is the principle membership status for practising accredited certifiers. Full members must be working full-time as an accredited certifier and must be committed to providing ethical and professional services to clients.
- Full (local government) membership - \$330 pa\***  
Full (local government) membership is available to individuals employed in local government. Associate (local government) membership provides networking and education opportunities and access to AAC products and services.
- Associate membership - \$220 pa\***  
Associate membership is available to individuals in related disciplines practising in the building industry, such as engineers, planners, architects and tradespersons that are actively involved in related disciplines, including non-accredited building surveyors. Associate membership provides networking and education opportunities and access to AAC products and services.
- Associate (local government) membership - \$220 pa\***  
Associate (local government) membership is available to individuals employed in local government. Associate (local government) membership provides networking and education opportunities and access to AAC products and services.
- Corporate membership - \$2,750 pa\* (unlimited members)**  
Corporate membership is available to companies/organisations that aim to be recognised as leaders in the building and development industry. These companies provide guidance and act as an example to others in relation to best practice, ethical standards and professionalism.  
Application forms are to be completed for every member covered under corporate membership.
- Student membership - \$11 pa\***  
Student membership is available to individuals studying to become accredited certifiers or studying in related disciplines, wishing to increase their awareness of the activities of accredited certifiers. Student membership will help you understand the role and responsibilities of an accredited certifier, as well as the issues that may affect their businesses.
- Retired membership - \$110 pa\***
